Public Comment:

Randall Stover: I talked to your zoning officer. His exact words were "I don't play favorites". He has a tendency to piss people off. I live in the R-1 Zone. I looked up the ordinances and you cannot have a horse or anything like that under five acres. The neighbor has goats and dogs. Pens must be 100' from property lines and grazing 50' from property lines. They don't have five acres to do all of this. They have to have a plan to collect all of the manure. What is going to be done? W. C. Vonada: Did you discuss this with Soil Conservation District? R. Stover: Yes, he has to come up with a plan to get rid of it all. W. C. Vonada will be consulting with the zoning officer to see what needs to be done with the property in possible violation.
